Be A Civilian Corps Advisor!

SUBMISSION DEADLINE: 15 January 2014

Background: The Civilian Corps Chief established its Board of Advisors in October 2012. The Board consists of 12 civilians from various occupations, career programs (CP), and experience levels from across the Command. The 12 positions are grouped into the following categories:

BOA MEMBER CATEGORIES:

CAT 1 - CP53 Admin

CAT 2 - CP53 Behavioral Health (BH)

CAT 3 - CP53 Clinical Professional

CAT 4 - CP53 Clinical Technical

CAT 5 - CP53 Dental

CAT 6 - CP53 Clinical/Non-Clinical Support CAT 7 - CP53 Nursing CAT 8 - CP53 Public Health

CAT 9 - (2 Members)

CP51 Admin or

CP11 Comptroller or

CP13 Supply Management or

CP32 Training

CAT 10 –(2 Members)

All Other CPs (2 Members)

After the first 12 months, we are beginning the first rotation of replacement cycles for 3 board member positions. These position openings are in the following occupational categories:

Category 2: CP53 Behavioral Health,

Category 4: CP53 Clinical Technical, and

Category 10: Specific Non-CP53 Career Programs (not in other Categories --see above).

If selected, you will work with the Civilian Corps Chief and the staff of the CSBPO Office to help shape the future of the Corps. You will learn about the Civilian Corps and the workings of the Corps Chief's office, gain hands-on experience working on and providing input to Civilian Corps initiatives, and collaborate with other Civilian Corps members.

Purpose: These appointed advisors will participate in committee meetings and collaborative review of issues related to the Civilian Corps and Army Medicine.

The duration of your appointment as a Civilian Corps advisor will be approximately 12-24-36 months and involves committee type meetings, document review, collaboration, etc., primarily conducted from your duty station.

This appointment is not designed to increase your workload or expand the duties of your job and does not infer any advancement or promotion opportunities. Occasional travel may be required. Travel costs and per diem will be funded by the Corps Chief's office.

WHEN: The Corps conducts quarterly Board meetings via VTC and strives to conduct annual onsite training sessions at Fort Sam Houston, TX. The next onsite training session is tentatively planned for late February or early March 2014. The Civilian Corps will pay travel /TDY costs.

How to Apply: Send us a short essay (250 words or less), with your supervisor's endorsement statement, through your chain of command as appropriate. In the essay, explain why you want to become an Advisor to the Civilian Corps, what you would bring to the Board and the Corps, and what you will take back to your organization and fellow Corps members should you be selected.
