AMEDD Civilian Corps Chief Message # 84—Important Survey Reminders ++

Howdy All Y'all,

As you know from past messages that's a plural greeting here in Texas! It's time for a few more reminders before I take a couple of days of leave. There are several topics below but please pay particular attention to the first two. Here we go.

FEDERAL EMPLOYEE VIEWPOINT SURVEY (FEVS): Many of you may have already received an invitation to take the FEVS survey. The Office of Personnel Management conducts this survey annually across the Federal government. A couple of points to consider:

• I VERY STRONGLY encourage you to take a few minutes and complete this survey. It is your opportunity to make input, in our case, to the Army on how you see things going and to help identify areas where we can make improvement. Army is really working hard on the issues identified in previous years and is really emphasizing the survey this year. Help our Army Team and help yourself by taking advantage of this opportunity to speak out.

• You may get a notice of an invalid certificate when you try to take the survey. That is a known glitch in the system so it is OK to proceed to and complete the survey. Don't let this systems issue get in your way!

TALENT MANAGEMENT (TM) ASPIRATIONS SURVEY: As you know from a couple messages back (# 82), we are on the verge of starting our civilian TM program. The aspirations survey is ready to pilot and the folks in Pacific Region have been kind enough to offer to do our pilot study. For those in other commands, you can expect to have the final product available for your use in June. For those in the Pacific Region:

- You will receive the survey notice in the next couple of weeks to execute our pilot study
- PLEASE help us out by completing the survey; it's short (7 questions) and easy to do
- The survey itself will be in Army Career Tracker; the notification message will have instructions on how to get to the survey
- Oh by the way, once you complete the survey in the pilot program, you will not need to do it again when the final version comes out!
- REMEMBER this survey is your ticket into the TM program so BE SURE TO COMPLETE !!

DEPLOYMENT OPPORTUNITIES: We get questions about this type of opportunity on a regular basis. Well, here's a couple to think about! The Ministry of Defense Advisors (MoDA) program has released 2 European Command (EUCOM) Medical Advisor requirements as opportunities for interested individuals. There are positions in Ukraine and the country of Georgia. Unlike the previous Afghan deployments we told you about a couple of years ago, these are accompanied tours.
